2010 Annual Dues Notice

Dear Colleague:

Please find, on the reverse side of this page, your personalized Dues Notice for membership in the *American Association of Clinical Anatomists* for 2010. Once again this year, we offer you 3 convenient ways to submit your payment:

1. **Credit card ONLINE** through our secure server page in the Association web site. We accept *Visa* and *Mastercard* for your convenience.

2. **Credit card by MAIL or FAX:** Using this method you must not only include your credit card number and expiration date, but also the address to which the card's billing statement is sent (to verify the transaction if requested by the card issuer), and
3. **CHECK by MAIL** (personal, institutional, *etc.*). Please note that if you prefer to pay by check, *all payments must be in U.S. dollars drawn on a U.S. banking institution.*

Checks drawn on foreign checks and currencies cannot be accepted as the processing fees associated with collecting these funds often come to over 50% of the check's value.

For those paying by institutional check, especially if there are more than one member at your campus, please make certain that the issuing office **INCLUDES** on the check the **MEMBERS' NAME(S)**.

Prior to payment, **PLEASE CHECK YOUR STATUS** using our Membership Database on the AACA Website. If you have any questions or problems, please contact Neil (nsnorton@creighton.edu). Our annual dues remain extremely low (\$125 for regular members). In 2010, \$110 of this amount goes to pay for your hard copy subscription. Due to this cost, it is extremely important that we ensure only those members in good standing receive the journal. We have moved to a January-December dues format meaning that any member that has not paid their 2010 Annual Dues by February 15th, 2010 will not receive any 2010 issues of the journal until their dues are paid. Once paid, you will simply receive all of the back issues for that calendar year rather than the June-July method used in the past. If you have let your membership lapse for one or more years, please contact Neil (nsnorton@creighton.edu) for the easiest way to reconcile your membership issue.

PLEASE NOTE that we have added a **NEW** category for our **Senior Members**. In the past, Senior Members have either paid \$75 and received a paper copy of the journal or paid \$0 and received no journal. Now, we have added a category for Senior Members in which they can pay \$30 and receive electronic access to the journal.
